#### **4.1. Description of first aid measures**

In case of skin contact:

Remove contaminated clothing, wash skin with soap and rinse thoroughly with water.  
Do not use solvents or thinners.

In case of eyes contact:

In case of contact with eyes, rinse immediately with plenty of water and seek medical advice.

Wash thoroughly under a trickle of water (warm if possible) for several minutes, holding the eyelids open under the stream of water.

In case of Ingestion:

Immediately consult a physician and show the label.  
Do not induce vomiting.

Whatever the amount of product ingested, do not eat and do not drink.

In cases of acute distress, contact the nearest poison centre.

In case of Inhalation:

Remove casualty to fresh air and keep warm and at rest.

Assure fresh air breathing

Allow the victim to rest.

Internal haemorrhage in case of ingestion

Effects result from the inhibition of blood coagulation as Bromadiolone interacts with vitamin K1.
