

INSTRUCTIONS FOR USE

Insecto Pro Formula Insect Fogger+ is an automatic 'one shot' fogging aerosol. Firstly ensure that all people, animals, pets (including terrariums and aquariums) and foodstuffs are removed from the area to be treated. Firmly close all doors and windows of the area being treated. To activate simply press the nozzle down until it clicks into position and starts to dispense. Place the aerosol on a non-sensitive surface and immediately leave the premises. Once the fogger has been activated it will empty entirely. Coverage: 150ml = 187.5m²

APPLICATION RATE

Place the aerosol on a non-sensitive surface in the middle of the area being treated. Press down nozzle until it locks - it will start to automatically dispense the contents. Leave the area immediately and don't re-enter for a minimum of 2 hours to allow the Insecto Pro Formula Insect Fogger+ to work effectively. Once you return to the area, open all doors and windows to ventilate thoroughly (airing between 1 hour to half a day depending on the area being vented)

Application Method: SPACE TREATMENT. ACTIVATE THE AEROSOL UNTIL THE MECHANISM JAMMED. IMMEDIATELY LEAVE THE PREMISES AND LET THE PRODUCT ACT FOR AT LEAST 2 HOURS. THOROUGHLY VENTILATE THE TREATED ROOM BEFORE ENTERING (AIRING BETWEEN 1 HOUR AND HALF A DAY, DEPENDING ON THE POSSIBLE VENTILATION LEVEL).
