**DIRECTIONS FOR USE**

**Bedbugs & Fleas:**

Apply 10g directly to bedframes, cracks, crevices, walls, floor areas (inc carpets) and furniture. Do not apply to mattresses, bedding or soft furnishings – remove and change pet bedding.

**Cockroaches:**

Apply 10g directly to all areas where activity is found such as cracks, crevices, other hiding places and runways. Do not apply to soft furnishing. Repeat treatment as necessary to maintain adequate control.

**Ants:**

Apply 10g directly to the ant's nest and NOT scattered, runs or areas of high ant activity. Treated areas must be protected from any rainfall, if unprotected an additional application may be required.

**Wasp & Hornet Nests:**

Apply 50g directly to the entrance of the nest, a repeat treatment may be required especially after rainfall. You may need to wear protective clothing to avoid any stings.

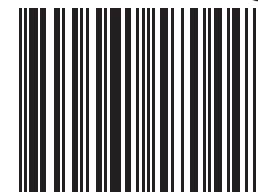
